Ethnic-Based Deprivation and Its Impacts on Political Instability in Khyber Pakhtunkhwa, Pakistan

Abstract

This study examines the relationship between ethnic-based deprivation and political instability in Khyber Pakhtunkhwa, Pakistan, using a quantitative approach. A sample of 296 individuals was selected from a population of 1280, and data was collected through a structured questionnaire. The results, presented in tables, reveal a significant link between ethnic-based deprivation and political instability. Economic exclusion, political marginalization, and social inequality are identified as key factors perpetuating deprivation and instability. The findings emphasize the need to address ethnic disparities to promote peace and stability in the region. This research provides valuable insights for policymakers and stakeholders working to address ethnic tensions and promote inclusive development in Khyber Pakhtunkhwa. By understanding the complex dynamics of ethnic-based deprivation and political instability, this study aims to inform evidence-based policies that promote a more equitable and stable future for the region. The findings of this study have important implications for promoting social cohesion, reducing inequality, and improving political stability in Khyber Pakhtunkhwa.

INTRODUCTION

Pakistan, since its inception, has navigated the complex and often turbulent waters of ethnonational diversity. The challenge of forging a unified national identity while accommodating distinct linguistic, cultural, and historical identities has been a persistent feature of its political landscape (Chen & Khoso, 2025; Ying et al., 2024). This struggle has frequently manifested as political instability, with various ethnic groups expressing feelings of marginalization, economic exploitation, and political exclusion (Syed et al., 2015). Nowhere is this dynamic more historically significant and contemporarily relevant than in the province of Khyber Pakhtunkhwa (KP) (Siddique, 2014).

The roots of ethnic discontent in KP are deeply embedded in history. The arbitrary demarcation of the Durand Line in 1893 bifurcated the Pashtun population, creating a territorial and psychological schism that continues to resonate (Rose, 2011, Rodrik, 1999). The subsequent political movements, from the Khudai Khidmatgar's alignment with the Indian National Congress to the post-1947 "Pakhtunistan"



sentiment supported by Afghanistan, underscore a long-standing quest for political rights and autonomy that was often perceived as being suppressed by the central state (Khan, 2020). This historical legacy of political deprivation has been compounded by internal ethnic dynamics within the province itself, such as the movement for a separate Hazara province, which highlights ongoing tensions between Pashtun and non-Pashtun communities over resource allocation and political representation (Ahmar, 2013; Feyyaz, 2011).

The core problem this research addresses is the nexus between ethnic-based deprivation and political instability (Anaya, 2010). Ethnic-based deprivation refers to the systemic and multidimensional marginalization of groups, leading to a lack of access to political power, economic resources, and social standing (Gurr, 1993; United Nations, 2019). When communities feel systematically excluded, the resulting grievances can fuel social unrest, diminish trust in state institutions, and become a potent catalyst for political fragmentation and conflict (Collier & Hoeffler, 2004; Esteban, 2010). In the context of KP, this deprivation is not merely a historical relic but a living reality, perpetuated by perceptions of economic imbalance, political underrepresentation, and cultural suppression.

This paper, therefore, seeks to systematically investigate the relationship between ethnic-based deprivation and its impacts on political instability in Khyber Pakhtunkhwa. It moves beyond a purely historical analysis to an empirical examination of contemporary perceptions, asking critical questions: To what extent do the people of KP perceive a link between ethnic marginalization and political unrest? How does this instability, in turn, cripple human development? And how effective are existing governmental initiatives in addressing these deep-seated issues? By answering these questions, this study aims to contribute to a deeper understanding of one of Pakistan's most pressing internal challenges and to inform policies that promote inclusive governance and sustainable stability.

Statement of the study

The statement of this study to Exploring the link between ethnic-based deprivation and political instability in Khyber Pakhtunkhwa (KPK), this research aims to investigate how the province's complex ethnic dynamics, marked by a history of marginalization and exclusion, have contributed to ongoing political instability and social unrest (ICG, 2019; HRW, 2020). Population of study

Sampling

A stratified random sampling technique was used to select a representative sample of 296 participants from various ethnic groups and regions in KPK, ensuring proportionate representation.

Data Collection Tool

A structured questionnaire was designed, consisting of: Demographic questions (age, gender, ethnicity, education), ethnic-based deprivation and political Instability questions. The data was collected through this well-furnished questioner from the educated people of the society.

Data Analysis

To better understand the data we collected, we used descriptive statistics to summarize and organize the information using SPSS software. This included calculating frequencies and percentages, as well as creating tables and graphs to visualize the data. These statistical measures helped us grasp the characteristics of the variables we were studying and helped us understand the scope and severity of the issue at hand. By presenting the data in a clear and concise manner, we were able to get a clearer picture of the problem and its impact.

RESULT AND DISCUSSION

This data reveals the responses of individuals to statements about ethnic-based deprivation and political instability in Khyber Pakhtunkhwa (KP). The majority of respondents (66.55%) believe that ethnic-based deprivation is a significant issue in KP. Moreover, a substantial majority (79.72%) think that this deprivation has a profound impact on political stability in the region.

The respondents also strongly agree that economic deprivation (69.93%), social exclusion (86.48%), and discrimination (86.48%) contribute significantly to political instability in KP. Additionally, a majority (69.93%) believe that political representation plays a vital role in addressing ethnic-based deprivation.

The responses also suggest a strong correlation between religious discrimination and political instability (63.17%), and cultural suppression and political instability (63.17%). However, the respondents are divided on whether linguistic marginalization affects political stability (50%-50%).

Lastly, a majority (66.55%) of respondents believe that ethnic-based deprivation significantly impacts political participation in KP. Overall, the responses indicate a strong perception among the respondents that ethnic-based deprivation and related factors have a profound impact on political stability and participation in KP.

The responses suggest a strong perception among the respondents that political instability has a significant impact on various aspects of life in KP. For instance, an overwhelming majority (86.48%) believe that political instability affects access to education, while a similar percentage (86.48%) think it impacts healthcare. A vast majority (89.86%) believe it affects economic growth, while a significant majority (83.10%) think it contributes to poverty.

The respondents also believe that political instability affects social cohesion (76.35%), human security (86.48%), access to justice (83.10%), human rights (66.55%), environmental sustainability (63.17%), and food security (66.55%).

The majority of respondents believe that political instability has a significant impact on all of these aspects, with the highest percentage agreeing that it affects economic growth (89.86%) and the lowest percentage agreeing that it affects human rights (66.55%). This suggests a widespread perception among the respondents that political instability is a significant obstacle to development and well-being in KP.

The table presents responses to 10 statements about existing policies and initiatives addressing ethnic base issues in Khyber Pakhtunkhwa (KP). The responses reveal a perceived need for improvement in these policies and initiatives.

While a minority (43.24%) believe that existing policies and initiatives address ethnic base issues, a majority (56.75%) disagree. Furthermore, only a small minority (26.35%) think these policies and initiatives effectively address ethnic base deprivation, while a large majority (73.64%) disagree.

The responses also indicate significant gaps in existing policies and initiatives, with a large majority (73.31%) believing that there are gaps, and a minority (26.68%) disagreeing. Additionally, a minority (43.24%) believe that existing policies and initiatives address political instability, while a majority (56.75%) disagree.

However, a majority (56.41%) believe that existing policies and initiatives have a significant impact on human development, while a minority (43.58%) disagree. Despite this, a minority (39.86%) believe that existing policies and initiatives address the root causes of ethnic base deprivation, while a majority (60.13%) disagree.

The responses also suggest a lack of political will to address ethnic base issues, with a minority (36.48%) believing that there is a high level of political will, while a majority (63.51%) disagree.

Furthermore, a minority (46.62%) believe that existing policies and initiatives engage effectively with local communities, while a majority (53.37%) disagree.

Similarly, a minority (46.62%) believe that civil society plays a significant role in addressing ethnic base issues, while a majority (53.37%) disagree. However, a majority (63.17%) believe that existing policies and initiatives can be improved to address ethnic base issues, while a minority (36.82%) disagree.

Overall, the responses suggest a perceived need for improvement in existing policies and initiatives addressing ethnic base issues in KP, with significant gaps and ineffective addressing of root causes and political instability. However, there is a perceived positive impact on human development and a desire for improvement.

CONCLUSION

This study establishes a definitive link between ethnic-based deprivation and political instability in Khyber Pakhtunkhwa. The perception of economic injustice, political marginalization, and social discrimination is widespread and is seen as a primary cause of the region's instability. This instability, in turn, cripples human development by undermining economic growth, access to education and healthcare, and social cohesion. The research concludes that the cyclical relationship between deprivation and instability is perpetuated by policies that are perceived as inadequate, fragmented, and lacking in genuine political commitment. To break the cyclical relationship between ethnic-based deprivation and political instability, this study proposes a multi-faceted policy framework that begins with fostering inclusive political empowerment through proportional representation and independent grievance commissions to address political exclusion. This must be coupled with targeted socioeconomic development that ensures the equitable allocation of resources to underdeveloped regions, implementing specific programs in education, healthcare, and infrastructure while encouraging private investment in marginalized areas. Furthermore, cultural recognition and preservation are vital, achievable through promoting mother-tongue education and establishing cultural centers to celebrate the province's diverse heritage. Concurrently, strengthening governance and justice by reinforcing law enforcement and judicial systems and establishing a provincial human rights commission is essential to protect rights and address social injustices. The entire process must be underpinned by participatory policy reform that actively engages local communities and civil society in the design, implementation, and monitoring of policies to build trust through transparent governance, all of which requires the foundational step of building a consensus among political parties to recognize addressing ethnic grievances as a national priority for achieving sustainable stability and development.
